

(6) (a) Possess, propagate, purchase, sell, kill, and exhibit any species of farm-raised deer.

(b) Sell or offer to sell the opportunity to hunt white-tailed, farm-raised deer that the person owns."

2. Page 40, line 23: after "hunting" insert "white-tailed".

3. Page 41, line 1: after "hunting of" insert "white-tailed".

4. Page 41, line 3: after "dead" insert "white-tailed".

5. Page 41, line 4: before "killed" insert "otherwise".

6. Page 41, line 5: after "hunting of" insert "white-tailed".

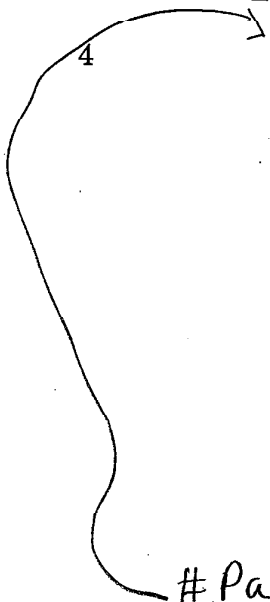
