8 (2) ANIMAL HEALTH SERVICES

9 (q) Inspection of captive cervids SEG B 250,000 -0.0e

10 2. Page 9, line 5: after that line insert:

11 "SECTION 1<sup>m</sup>. 20.115 (2) (q) of the statutes is created to read:

move from p. 2 line 4

MOVE

1 20.115 (2) (q) *Inspection of captive cervids*. Biennially, from the conservation  
2 fund, the amount in the schedule for inspection of captive cervids under 2001  
3 Wisconsin Act .... (this act), section 240m (1). ”.

4 SECTION 1<sup>e</sup> 20.115 (2) (ha) of the statutes is amended to read:”

5 3. Page 112, line 6: after “provisions” insert “; livestock markets, dealers,  
6 and truckers”.

7 4. Page 112, line 23: after that line insert:

8 “SECTION 240m. Nonstatutory provisions; inspection of captive cervids.

9 (1) REQUIREMENT. No later than the first day of the 7th month beginning after  
10 the effective date of this subsection, the department of agriculture, trade and  
11 consumer protection shall inspect all cervids that are in captivity in Iowa County and  
12 all counties that are adjacent to Iowa County for symptoms of chronic wasting  
13 disease.”

Morning Mary,

I unfortunately just talked to Kevin again and I need to add an amendment. This one is just an add on to the bill, it doesn't change anything in the bill. I want to mandate the inspection of all captive cervids in Iowa county (where chronic wasting disease just broke out) and all counties contiguous to Iowa county by DATCP. Also allocate \$250,000 in seg money from the DNR fish and wildlife account to offset cost, and mandate that the inspections are done within 6 months.

I didn't know if this might be Rebecca Treadwell's or not so I sent it to you.

Thank you for all the help Mary, and I know all of this is way to late. In priority order I guess this would go ahead of the last one I gave you on naming domestic animals.
