TO 2001 SENATE BILL 307

1 At the locations indicated, amend the bill as follows:

2 1. Page 103, line 7: after that line insert:

3 "(2m) WARNING NOTICE. (a) For a violation of a provision of this chapter, if the
4 alleged violator has not previously received a warning notice for a violation of the
5 same provision, a warning notice in lieu of a citation or complaint and summons shall
6 be issued. If the warning notice requires the alleged violator to remedy the effects
7 of the alleged violation, the warning notice shall specify the remedial action to be
8 taken and the date before which the remedial action must be completed.

9 (b) If a warning notice has been issued to an alleged violator under par. (a) and
10 the alleged violator fails to comply with the warning notice, a citation or complaint
11 and summons shall be issued for the violation.

1 (c) The department shall record the issuances of warning notices for purposes
2 of this subsection.”
