SENATE AMENDMENT ,  
TO 2001 SENATE BILL 307

1 At the locations indicated, amend the bill as follows:

2 1. Page 97, line 3: after that line insert:

3 "169.365 Nondisclosure of certain information. (1) In this section:

4 (a) "List" means a computer generated list compiled or maintained by the  
5 department that contains the personal identifiers of persons who hold licenses under  
6 this chapter.

7 (b) "Personal identifier" means the name, social security number, telephone  
8 number, street address, post-office box number, or zip code.

9 (2) (a) The department may not disclose any list, any personal identifier of a  
10 person holding a license under this chapter, or any information received by the  
11 department under s. 169.36 to another person.

12 (b) Paragraph (a) does not apply to a list, personal identifier, or information  
13 that the department furnishes to another state agency, a law enforcement agency, or

1 a federal governmental agency. A state agency that receives the list, the personal  
2 identifier or the information from the department may not disclose the list, personal  
3 identifier, or information to any other person other than a state agency, a law  
4 enforcement agency, or a federal governmental agency.”
