

## 2001 SENATE BILL 176

May 8, 2001 – Introduced by Senators GROBSCHMIDT, PLACHE, ROSENZWEIG, BURKE and SCHULTZ, cosponsored by Representatives OLSEN, HUBER, POCAN, PLALE, LA FAVE, KESTELL, WADE, M. LEHMAN, WOOD, GUNDERSON, LIPPERT, SYKORA, ALBERS, J. LEHMAN, TOWNSEND, PETROWSKI, GRONEMUS, OTT, POWERS and MCCORMICK. Referred to Committee on Education.

1     **AN ACT to amend** 16.974 (7) (d), 20.255 (1) (b), 20.255 (1) (c), 20.255 (1) (gb),  
 2           20.255 (1) (gh), 20.255 (1) (gL), 20.255 (1) (gs), 20.255 (1) (gt), 39.41 (1) (bm),  
 3           39.41 (1m) (c) 2., 39.41 (1m) (fm), 44.70 (2g), 46.041 (1) (a), 49.45 (39) (a) 1., 49.45  
 4           (39) (am), 49.45 (39) (b), 115.31 (1) (b), subchapter III (title) of chapter 115  
 5           [precedes 115.51], 115.53 (2), 115.53 (3) (a), 115.53 (4), 115.53 (5), 115.54, 121.05  
 6           (1) (a) 8., 121.54 (3) and 940.295 (2) (j); **to repeal and recreate** 115.51 (2) and  
 7           115.52; and **to create** 15.377 (2) of the statutes; **relating to:** the Wisconsin  
 8           School for the Deaf and creating a deaf and hard-of-hearing education council.

### ***Analysis by the Legislative Reference Bureau***

This bill changes the name of the Wisconsin School for the Deaf to the Wisconsin Educational Services Program for the Deaf and Hard of Hearing, specifies the duties of the Program, and creates a deaf and hard-of-hearing education council to advise the state superintendent of public instruction on issues relating to the education of children who are deaf or hearing impaired. The bill also requires the legislative audit bureau to conduct a performance evaluation audit of the Program during the 2004–05 fiscal year.

The bill authorizes the Program to provide services at any location in the state and to operate regional satellite facilities throughout the state.

***The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:***

1           **SECTION 1.** 15.377 (2) of the statutes is created to read:

2           15.377 (2) DEAF AND HARD-OF-HEARING EDUCATION COUNCIL. There is created a  
3 deaf and hard-of-hearing education council in the department of public instruction.  
4 The council shall consist of the following members, at least 3 of whom must be  
5 hearing impaired, appointed by the state superintendent of public instruction for  
6 3-year terms:

7           (a) Two parents of children who are hearing impaired.

8           (b) One licensed teacher of pupils who are hearing impaired.

9           (c) One person who is licensed as a speech-language pathologist under subch.  
10 II of ch. 459.

11           (d) One school district special education director.

12           (e) One person who is licensed as an audiologist under subch. II of ch. 459 and  
13 whose expertise is in educational audiology.

14           (f) One person who is experienced in educating the hearing impaired, or in  
15 educating teachers of the hearing impaired, and is affiliated with an institution of  
16 higher education.

17           (g) One person who is an instructor in a technical college interpreter training  
18 program.

19           (h) One person employed as an educational interpreter.

20           (i) Three other members.

5 Wisconsin Center for the Blind and Visually Impaired or the Wisconsin School  
6 Educational Services Program for the Deaf and Hard of Hearing may submit, and  
7 the department shall allow, claims for common carrier transportation costs as a  
8 school medical service unless the department receives notice from the federal health  
9 care financing administration that, under a change in federal policy, the claims are  
10 not allowed. If the department receives the notice, a school district, cooperative  
11 educational service agency, the Wisconsin Center for the Blind and Visually  
12 Impaired, or the Wisconsin School Educational Services Program for the Deaf and  
13 Hard of Hearing may submit, and the department shall allow, unreimbursed claims

**SECTION 20.** 115.51 (2) of the statutes is repealed and recreated to read:

115.51 (2) “Hearing impaired” has the meaning given in the rules promulgated by the state superintendent to define “hearing impairments” under s. 115.76 (5) (a) 2.

**SECTION 21.** 115.52 of the statutes is repealed and recreated to read:

**115.52 Wisconsin Educational Services Program for the Deaf and Hard of Hearing. (1) DEFINITION.** In this section, “program” means the Wisconsin Educational Services Program for the Deaf and Hard of Hearing.

**(1m) PURPOSE.** The purpose of the program is to serve as a statewide educational resource relating to hearing impairments to benefit all Wisconsin children who are hearing impaired.

**(2) GOVERNANCE.** The state superintendent shall maintain and govern the program’s facilities. The state superintendent shall appoint an individual who has training and experience in educating pupils who are hearing impaired to serve as the director of the program.

**(3) SERVICES.** The program shall provide services that benefit children throughout the state who are hearing impaired.

**(a) School.** 1. ‘Residents 3 to 20 years old.’ The program shall operate a school at which any resident of this state 3 to 20 years old who is hearing impaired, and for the duration of a school term any resident of this state who is hearing impaired and

1 becomes 21 years old during that school term, shall be received and taught free of  
2 charge if the individualized education program for the resident under s. 115.787 and  
3 the educational placement under s. 115.79 specify the school operated by the  
4 program as the appropriate placement.

5 2. 'Residents 21 years old or older.' The state superintendent may admit to the  
6 school operated by the program a resident of the state who is hearing impaired and  
7 is 21 years of age or older prior to the beginning of a school term upon the payment  
8 of fees fixed by the state superintendent and upon the recommendation of the  
9 secretary of health and family services, the director of the technical college system,  
10 or the director of the program.

11 3. 'Nonresidents.' A nonresident of this state, who is hearing impaired, who  
12 either is 3 to 20 years old or becomes 21 years old during a school term, whose  
13 individualized education program under 20 USC 1414 (d) and educational placement  
14 specify the school operated by the program as the appropriate placement, and who  
15 is capable of receiving instruction may be received at the school upon payment in  
16 advance of the fees fixed by the state superintendent, but no nonresident may be  
17 received to the exclusion of a resident pupil.

18 4. 'Pupil use of residential facilities.' Except as provided in sub. (4), the director  
19 of the program shall make the residential facilities of the program available to all  
20 pupils received at the school operated by the program.

21 5. 'School term.' The state superintendent shall fix the period of the school term  
22 at the school operated by the program at not less than 38 weeks, prescribe the school  
23 sessions, and confer diplomas upon meritorious pupils who have completed the  
24 prescribed curriculum. Pursuant to a pupil's individualized education program  
25 under s. 115.787, a pupil may be placed at the school for less than a school term.

1           6. ‘Transportation.’ The program may provide transportation for resident  
2 pupils at the school operated by the program.

3           (b) *Other statewide services.* The program may do any of the following:

4           1. Provide evaluation services to assist local educational agencies, cooperative  
5 educational service agencies, county children with disabilities education boards,  
6 private schools, and others.

7           2. Provide technical assistance and consultation services to local educational  
8 agencies, cooperative educational service agencies, county children with disabilities  
9 education boards, private schools, and others.

10          3. Develop and disseminate curriculum and instructional materials.

11          4. Provide in-service and other training to teachers and other staff serving  
12 pupils who are hearing impaired.

13          5. Provide training, technical assistance, and consultation services for parents  
14 of children who are hearing impaired and for professionals who work with children  
15 who are hearing impaired.

16          6. Provide access to educational materials to children who are hearing  
17 impaired.

18          7. Loan books and other materials from the library described in par. (c) 2.

19          8. Serve as a clearinghouse for information about children who are hearing  
20 impaired.

21          9. Teach American sign language, and teach other subjects using American  
22 sign language, through the use of distance education technology.

23          10. Rent or lease technological materials and assistive technology devices, as  
24 defined in s. 115.76 (1), to local educational agencies, cooperative educational service  
25 agencies, county children with disabilities education boards, and private schools.

1           11. Facilitate the preparation of teachers of pupils who are hearing impaired  
2 by providing assistance to teacher preparation programs.

3           12. Provide other statewide services that relate to the education of children who  
4 are hearing impaired.

5           (c) *Additional services.* 1. ‘Birth to 3 services.’ The program may provide  
6 instruction or services, or both, for children who are under the age of 3 and are  
7 hearing impaired and their parents. The instruction or services are subject to the  
8 approval of, and shall comply with requirements established by, the department.

9           2. ‘Library.’ Educational media and materials acquired by the program  
10 constitute a circulating collection for persons who are hearing impaired. The  
11 collection shall be kept at the program’s facility and be under the supervision of its  
12 director. All school age children of the state who are hearing impaired may use the  
13 media and materials upon compliance with criteria established by the director of the  
14 program and approved by the state superintendent.

15           3. ‘Summer programs.’ The program shall provide summer programs each year  
16 for children who are hearing impaired.

17           4. ‘Independent living skills.’ With the approval of the state superintendent,  
18 the program may allow individuals to receive instruction in and practice  
19 independent living skills in state-owned housing at the program’s facility in  
20 Delavan.

21           (d) *Provision of services.* In addition to providing services at the program’s  
22 facility in Delavan, the program may provide services at any location in the state and  
23 may operate regional satellite facilities throughout the state to provide services.

24           **(4) NONDISCRIMINATION.** All pupils in the program may equally and freely enjoy  
25 the benefits and privileges of the program, have the use of the library and books of

1 instruction, and receive board, lodging, and linens, without discrimination, except  
2 that the director of the program may determine that board, lodging, and linens may  
3 not be provided to an individual because appropriate services are not available for  
4 that individual at the program's residential facilities.

5 (5) CHARGES. The state superintendent may charge for meals, living quarters,  
6 laundry, and other services furnished to employees of the program and their families.  
7 The state superintendent may charge for services furnished to visitors to the  
8 program's facilities and participants in training programs and institutes.

9 (6) LEASING OF SPACE. The state superintendent may lease space at the  
10 program's facilities in Delavan that is not required by the program to any person if  
11 the state superintendent determines that the use will not be inconsistent with the  
12 operation of the program.

13 (7) AUDIT. In the 2004–05 fiscal year, the legislative audit bureau shall perform  
14 a performance evaluation audit of the program. The bureau shall submit copies of  
15 the audit report to the chief clerk of each house of the legislature for distribution to  
16 the appropriate standing committees under s. 13.172 (3) by June 30, 2005.

17 **SECTION 22.** 115.53 (2) of the statutes is amended to read:

18 115.53 (2) Arrange for vocational, trade or academic training for any pupil in  
19 either the school operated by the Wisconsin Center for the Blind and Visually

15 impaired and who is between the ages of 6 and 21 is deprived of a suitable education  
16 by the failure of the person having the care and custody of the child to provide a  
17 suitable education, the judge shall order the person to bring the child before the  
18 judge. If the material allegations of the affidavit are denied, the judge shall subpoena  
19 witnesses and hear testimony. If the allegations are admitted or established, the  
20 judge may order the child sent to the school operated by the Wisconsin School  
21 Educational Services Program for the Deaf and Hard of Hearing, the school operated  
22 by the Wisconsin Center for the Blind and Visually Impaired or to some class or other  
23 school for instruction, but the order may not make a direct charge for the class or  
24 school against any county.
