I'm not sure if you'd be the one to do this draft or not. Senator Grobschmidt would like a bill drafted that would require safety gates on the front of school buses. He believe's that there has been a similar bill drafted a number of years ago. This is in response to an accident in our district where a 5 year old was run over by a school bus. The report indiciated that they believe that the tragedy could have been avoided had there been safety gates on the bus.

It is his undersstanding that the device would, when the bus is stopped, extend forward from the front of the bus. The ppurpose would be to require exiting passengers to walk far enough in front of the bus so that the driver could see the passenger moving into the path of the bus. Senator Grobschmidt thinks that Laidlaw bus Company has these devices because they are a national company and a number of states do require these devices.

Under current law, school buses must be painted yellow and black and must have the words "SCHOOL BUS" in black letters at least b inches high written on the front and back of the bus. A school bus painted in this manner may not be operated unless it is equipped with flashing red signals and with a 360-degree flashing white strobe light. Current law also allows the department of transportation (DOT) to prescribe rules requiring additional equipment for school buses. These DOT rules currently require every school bus painted yellow and black to be equipped with a stop signal arm, and also provide specifications for the stop signal arm. These rules also allow, but do not require, a school bus to be equipped with a safety control arm mounted on the right side of the bumper. Hat is

This bill requires any school bus painted yellow and black to be equipped with a retractable crossing gate on the frantiof the busthat, when in use, prevents children from crossing in front of the bus in such proximity that they are not visible to the bus The bill also requires DOT to prescribe rules for the specifications, installation, and operation of these crossing gates. Any person who operates a school bus that is not equipped with the required crossing gate may be required to forfeit not less than \$10 nor more than \$200.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

**SECTION 1.** 347.445 of the statutes is created to read:

347.445 Crossing gates for school buses. No person may operate a school bus which is painted as provided in s. 347.44 unless it is equipped with a retractable crossing gate on the front of the bus that, when in use, prevents children from crossing in front of the school bus in such proximity that they are not visible to the operator of the school bus from the operator's seat. The secretary shall prescribe rules for the specifications, installation, and operation of crossing gates required under this section.

#### SECTION 2. Effective date.

(1) This act takes effect on the first day of the 7th month beginning after publication.
