Anne,

As Yvonne and I mentioned today, there are a few technical changes that need to be made to AB 488 in order to use TANF maintenance-of-effort funds for second chance homes grants:

1. Delete the current language in Section 1, which would modify an existing PR-S appropriation in DHFS, and instead create a new GPR appropriation [s. 20.435(3)(f)] in DHFS for the second chance homes program.

2. Add a section in the new GPR appropriation stating that any second chance homes funding not expended by June 30 of each year would be transferred to DWD's GPR appropriation for W-2 and other public assistance administration and benefits [s. 20.445(3)(dz)] so that DWD would be able to meet its TANF maintenance-of-effort requirement if DHFS does not spend all funds appropriated.

3. Delete Section 34, which adds second chance homes to the list of TANF allocations in DWD. This section is not needed because second chance homes funding would not be channeled through DWD.

4. Delete Section 9258(1)(a)

5. Delete all references to fiscal year 2001-02 and insert the dollar figure desired for second chance homes grants for 2002-03 in all applicable sections of the legislation. I am assuming that \$0 will still be used throughout the bill.

Anne,

Yvonne and I looked over the senate amendment draft. Section 1g needs to be amended to reflect that any funds that have not been **expended** need to be transferred to DWD on June 30 of each year. Similar language was put in Act 16 in Section 20.435(7)(bc) for substance abuse grants.

Delete "the unencumbered" on Page 1, line 13 and delete lines 1-2 on page 2. Replace this with: the department shall transfer from this appropriation account to the appropriation account for the department of workforce development under s. 20.445(3)(dz), funds allocated by the department under s. 46.997(2)(a) and s.46.997(4) but unexpended by June 30 of each year.

That is the only change we have.
