2 1. Page 1, line 9: after "prohibitions," insert "eliminating the liability of an  
3 employee, agent, or independent contractor for selling or providing for no or nominal  
4 consideration cigarettes or tobacco products to a minor,".

5 2. Page 4, line 5: after that line insert:

6 "SECTION 1m. 134.66 (2) (a) of the statutes is amended to read:

7 134.66 (2) (a) No retailer, manufacturer, distributor, jobber, or subjobber, no  
8 agent, employee or independent contractor of a retailer, manufacturer, distributor,  
9 jobber or subjobber and no agent or employee of an independent contractor may sell  
10 or provide for nominal or no consideration cigarettes or tobacco products to any  
11 person under the age of 18, except as provided in s. 254.92 (2) (a). A vending machine  
12 operator is not liable under this paragraph for the purchase of cigarettes or tobacco

1 products from his or her vending machine by a person under the age of 18 if the  
2 vending machine operator was unaware of the purchase.

3 SECTION 1p. 134.66 (2) (am) of the statutes is amended to read:

4 134.66 (2) (am) No retailer, manufacturer, distributor, jobber, or subjobber, no  
5 agent, employee or independent contractor of a retailer, manufacturer, distributor,  
6 jobber or subjobber and no agent or employee of an independent contractor may  
7 provide for nominal or no consideration cigarettes or tobacco products to any person  
8 except in a place where no person younger than 18 years of age is present or  
9 permitted to enter unless the person who is younger than 18 years of age is  
10 accompanied by his or her parent or guardian or by his or her spouse who has  
11 attained the age of 18 years.".
