March 16, 1999 - Introduced by Representatives KAUFERT, OTT, KLUSMAN, UNDERHEIM, WIECKERT, OLSEN, ~~SENATL~~, KESTELL, PETROWSKI and LADWIG, cosponsored by Senators SHIBILSKI, ELLIS, COWLES, DECKER, ROESSLER and FARROW. Referred to Committee on Natural Resources.

1 AN ACT to amend 29.569 (3) (b); and to create 29.569 (3) (bm) of the statutes;  
2 relating to: the period of time during which sturgeon spearing licenses may  
3 not be issued.

**Analysis by the Legislative Reference Bureau**

Under current law, a sturgeon spearing license may not be issued during the open season for ~~the~~ spearing ~~of~~ rock or lake sturgeon (nonissuance period). The open season is currently set by rule promulgated by the department of natural resources ~~to begin~~ to begin the second Saturday in February and to continue for 16 consecutive days.

This bill changes this nonissuance period so that it begins on the October 1 preceding the open season and ends on the last day of the season. The bill also excepts two groups of persons from this prohibition on being issued licenses during this period. Residents who turn 14 years old during the nonissuance period may be issued a license during that period. Also, residents who are in the armed forces outside this state and who are on furlough or leave may be issued a license during the nonissuance period.

For further information see the *state and local* fiscal estimate, which will be printed as an appendix to this bill.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

ASSEMBLY BILL 210

SECTION 1

1 SECTION 1. 29.569 (3) (b) of the statutes is amended to read:

2 29.569 (3) (b) *Restrictions on issuance of sturgeon spearing licenses during the*  
3 *open season.* No Except as provided in par. (bm), no sturgeon spearing license may  
4 be issued during a period beginning ~~when~~<sup>on</sup> October 1 and ending on the last day of the  
5 open season for the spearing of rock or lake sturgeon that follows that October 1.

6 SECTION 2. 29.569 (3) (bm) of the statutes is created to read:

7 29.569 (3) (bm) *Exceptions.* A sturgeon spearing license may be issued during  
8 a period beginning ~~when~~<sup>on</sup> October 1 and ending on the last day of the open season for  
9 the spearing of rock or lake sturgeon that follows that October 1 to any of the  
10 following:

11 1. A person who is a member of the U.S. armed forces <sup>✓</sup> who exhibits proof that  
12 he or she is a resident, is in active service with the armed forces outside this state,<sup>✓</sup>  
13 and is on furlough or leave.

14 2. A person who is a resident and who has attained the age of 14 during that  
15 period.

16 SECTION 3. **Effective date.**

17 (1) This act takes effect on the September 1 after publication.
