The social worker section of the examining board shall grant a clinical social 10 worker license under section 457.08 (4) of the statutes, as affected by this act, to any 11 person who holds a valid independent clinical social worker certificate that was 12 granted by the social worker section of the examining board before the effective date 13 of this subdivision. 14 2. 24 4. The appropriate section of the examining board shall grant a temporary
25 social worker, marriage and family therapist, or professional counselor license under

section 457.14 (1) of the statutes, as affected by this act, to any person who holds a 1 2 valid temporary social worker, marriage and family therapist, or professional 3 counselor certificate that was granted by that section of the examining board before 4 the effective date of this subdivision. A temporary license granted pursuant to this 5 subdivision is valid only for the period of time designated by the section of the 6 examining board for the temporary certificate granted to the person. If the 7 temporary certificate was renewed once by the section, the temporary license may 8 not be renewed.
