**Assumptions Used in Arriving at Fiscal Estimate**

State costs: The department would need to annually update the minimum wage rates and inform employers through a mass mailing. The department would incur \$75,000 in annual costs (150,000 pieces of mail at \$0.50 per piece to cover postage, printing and materials) for the mass mailing and updating the minimum wage regulations.

Passage of the legislation will result in the department receiving an additional 200 complaints per year alleging violations of state minimum wage regulations. Part of the increased workload will be due to the substantial increase (32%) in the current minimum wage. Another part of the increased workload will result from the fact individuals will be more likely to file minimum wage complaints with the department rather than the federal government since Wisconsin's minimum wage rates will be higher than the federal rates. The department will need one additional Equal Rights Officer-Senior (\$59,400 total annual cost, including \$47,900 in salary and fringe benefits and \$11,500 for supplies and services, and one time costs of \$6,500 for equipment and office furnishings) to investigate and resolve the additional complaints each year. Additionally there will be one time costs of approximately \$2,000 to reprint other related informational materials.

Local Costs: Government units who currently employ workers at or near the present minimum wage will experience increased costs when the state minimum wage is increased with passage of this legislation. The department lacks sufficient data to determine the exact number of workers who may be affected or the total cost to various levels of government.

Adoption of this legislation will increase the annual salary of one full-time minimum wage employee from \$10,712 to \$14,144, an increase of \$3,432 (32%). The increase in annual salary for a full-time adult agricultural employee would be from \$8424 to \$13,520, an increase of \$5,096 (60%).
