SUBJECT: PER DIEM SCHEDULE

The Assembly is implementing a new payroll system called Lawson. This program will alter the procedures presently being used for processing per diem checks. With the new system the first of the month is the primary processing day for per diem. Per diem sheets ***turned in on the last working day of the month*** will be processed on the first working day of the month. Per diem sheets turned in after the last working day of the month will be scheduled as follows:

Sheets turned in on Monday or Tuesday can expect a check on Friday.

Sheets turned in on Wednesday, Thursday or Friday can expect a check on Tuesday of the following week.

The 16th to the 23rd of each month is a blackout period meaning no per diem sheets will be processed. The reason for this is that the system is processing monthly payroll. After the 23rd the above schedule will be resumed.

To further implement the process of a paperless Legislature your per diem sheets will be emailed to your office. In return, your office can fax or email a signed copy back to the Chief Clerk's office @ 266-5617. This process will eliminate the possibility of lost Inter-D mail and speed-up processing time.
