**ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD
REPEALING, RENUMBERING, AMENDING, REPEALING AN RECREATING, AND
CREATING RULES**

The Wisconsin Natural Resources Board proposes an order to repeal NR 10.106(2)(d) 2 and 10.117; renumber and amend NR 10.106(2)(d) 3; amend NR 1.15(2)(a), 10.001(3t), 10.01 (3)(e)1 and 2, 10.01(3)(em), (es) and (h)1.a., 10.09(1)(a)2, 10.104(10)(b), 10.106(2)(a) and (b), 12.16(2)(a) and 19.80(4)(a)5; repeal and recreate NR 10.01(3)(e) 6. and 10.28(1); and to create NR 1.15(2)(am) and (at), 10.01(3)(ev) and (ez), and 10.105(3) relating to deer hunting and the wildlife damage abatement and claims program.

Analysis Prepared by Department of Natural Resources

Statutory Authority: ss. 29.014, 29.889 and 227.11 Stats.

Statutory interpreted: ss. 29.177, 29.181, 29.361 and 29.889, Stats.

Section 1. Adds hunter success in harvesting and seeing deer and public deer viewing opportunities to the list of criteria for determining deer population goals.

Section 2. Develops standards for tolerable levels of deer damage to crops. Requires the department to lower the overwinter goal in deer management units that exceed the tolerable levels in 2 years out of a 3 year period.

Sections 3, 11 and 12. Updates references to a newly created paragraph.

Section 4. Creates a 4-day December antlerless only deer hunting season.

Sections 5 and 7. Creates a consistent hunting season framework for all metropolitan deer management units which includes a 3 week gun deer season starting the Saturday prior to the Thanksgiving holiday and a bow season that continues through the gun deer season and the month of January.

Section 6. Extends the late bow season to the Sunday closest to January 15.

Section 8. Extends the muzzleloader deer season 3 days.

Section 9. Establishes a one day youth gun deer hunt on the Saturday closest to Oct. 24.

Section 10. Allows the Department to modify the deer hunting season where normal seasons and permits are not expected to bring a deer population to within 20% of a unit's population goal. Establishes the special herd control modifications to the deer season including a 4 day October antlerless deer season and the earn-a-buck season after 2 years of October hunts. Establishes a formula for establishing herd control seasons, and eliminates the requirement of public meetings in affected units and natural resources board approval for each zone T unit each year. Expands DNR authority to administer herd control seasons from farmland deer management units to all deer management units.

Section 13. Clarifies that antlerless deer permits have to be used in the unit or units specified on the permit.

Sections 14, 15, 16, 17 and 18. Requires all deer killed with a gun or bow to be registered in the deer management unit of kill or an adjoining unit.

Section 19. Repeals section describing deer season modifications as this has been recreated in section 7.

Section 20. Identifies deer management units which are closed to the December deer hunting season.

Sections 21 and 22. Requires farmers enrolled in the Wildlife Damage Abatement Claims Program (WDACP) in a given year who experiences \$1,000 or more damage in that year be automatically issued a shooting permit by February 15 of the following year, with the required harvest objective of 80% of the harvest quota by September 15 in order to qualify for the benefits of the WDACP for the current year.

Section 1. NR 1.15 (2)(a) is amended to read:

NR 1.15(2)(a) *Deer population goals.* The department shall seek to maintain a deer herd in balance with its range and at deer population goals reasonably compatible with social, economic and ecosystem management objectives for each deer management unit. Deer population goals are to be based on:

1. Carrying capacity as determined by unit population responses to habitat quality and historical records of winter severity.
2. ~~The demand for deer hunting~~ Hunter success in harvesting and seeing deer and public deer viewing opportunities.
3. Ecological and economic impacts of deer browsing.
4. Disease transmission.
5. Concern for deer-vehicle collisions.
6. Chippewa treaty harvest.
7. Hunter access to land in a deer management unit.
8. Ability to keep the deer herd in a deer management unit at goal.
9. Tolerable levels of deer damage as described in par. (am).

Section 2. NR 1.15 (2)(am) and (at) are created to read:

NR 1.15(2)(am) *Tolerable levels of deer damage to crops.* Deer damage to crops in a deer management unit exceeds tolerable levels when the crop damage is greater than 2.5 times the median in 2 of the following 4 indicators:

1. Appraised deer damage losses determined through the wildlife damage program under s. 29.889, Stats., per 100 overwinter deer.
2. Appraised deer damage losses determined through the wildlife damage program under s. 29.889, Stats., per square mile of land in the deer management unit.
3. Appraised deer damage losses determined through the wildlife damage program under s. 29.889, Stats., per square mile of agricultural land in the deer management unit.
4. Number of claims for deer damage submitted through the wildlife damage program under s. 29.889, Stats., per 100 square miles of total land.

Note: The crop damage data used for these evaluations are adjusted to omit damage losses to high valued crops such as cranberry, orchard, Christmas tree, truck farm crops, etc. where low deer numbers can still cause high losses, and where effective abatement is available in the form of

8 foot high deer barrier, high tensile woven wire fences. The focus of the "tolerable levels" criteria is on chronic damage losses caused by high deer populations.

(at) If crop damage in a deer management unit is above the tolerable limit in 2 years out of a 3 year period prior to a current unit review under s. NR 10.104(3), the department shall consider reducing the goal if intolerable levels of damage are likely when the herd is at goal. If damage in a deer management unit exceeds tolerable levels when the herd is at goal in 2 years out of a 3 year period prior to a current unit review under s. NR 10.104(3), the department shall reduce the population goal in that unit, unless a goal reduction is not expected to alleviate intolerable levels of deer damage.

NR 10.001(3t) "Bonus deer hunting permit" for purposes of s. 29.181, Stats., means any additional carcass tags issued under s. NR ~~10.117~~ 10.01(3)(ez), any antlerless deer permits issued under s. NR 10.01(3)(ev) *Special youth antlerless deer hunt event.* Persons 12 years of age or older but under the age of 16 years of age who possess a certificate of accomplishment under s. 29.591, Stats., or its equivalent from another state or province, may hunt antlerless deer with a gun on the Saturday nearest October 24 in deer management units not included in a deer herd control hunt under s. NR 10.01(3)(ez). Allowable types of guns are those authorized on the first day of the regular gun deer season under s. NR 10.01(3)(e). The bag limit is one antlerless deer per hunter's choice or antlerless deer permit issued under s. NR 10.104. Youth who are first time graduates of the hunter education program may use their certificates of accomplishment in place of a hunter's choice permit issued under s. 29.177, Stats., to take an antlerless deer. Hunters shall be accompanied by an adult 18 years of age or older. One adult may not accompany more than 2 hunters and all other hunting regulations apply. Blaze orange requirements under s. 29.301(2), Stats., apply to all hunters on this day except waterfowl hunters.

Section 10. NR 10.01 (3)(ez) is created to read:

NR 10.01(3)(ez) *Special deer herd control hunt.* 1. The department may, upon making the findings in subd. 2., modify the deer hunting seasons and deer permit issuance procedures as described in this paragraph for any deer management unit to reduce the deer population nearer to the overwinter population goals established in s. NR 10.104. Modifications to the deer season shall consist of:

- a. A 4-day antlerless only deer season allowing the use of bows and guns starting on the Thursday nearest October 22. Allowable types of guns are those authorized on the first day of the regular gun deer season under s. NR 10.01(3)(e). Antlerless deer may be tagged with the back tag issued with each deer license, a special permit under subd. par. 1.b., or bonus permits issued under s. 29.181, Stats.
- b. Special permits for antlerless deer under s. 29.177, Stats., shall be issued free of charge at

the rate of one permit per license authorizing deer hunting or 2 permits per conservation patron license. The permits may be used to hunt and tag deer during any of that year's deer seasons for the units specified under subd.1.

c. The backtag issued with a regular deer license is valid for taking and tagging a deer of either sex during the regular 9 day gun season under s. NR 10.01(3)(e).

d. If after 2 consecutive seasons, as described in subd. par. 1.a., the department determines a third season, as described under subd. par. 1.a., is unlikely to reduce the deer population to within 20% of the overwinter population goal established in s. NR 10.104 for the same deer management unit or units in the subsequent year, hunters shall harvest or tag an antlerless deer in that unit or units with either a bow or a gun during any deer season or with an agricultural shooting permit, before they may harvest a buck with either weapon in that unit or units. One antlerless deer is required to authorize harvest of one buck in that unit or units for each archery and gun deer license. Deer harvested as described in this paragraph shall be transported in accordance with s. NR 10.105 (3).

e. If after a season as described in subd. par. 1.d. the department determines a season as described in subd. par. 1.a., is unlikely to reduce the deer population to within 20% of the overwinter population goal, established in s. NR 10.104, for the same deer management unit or units in the subsequent year, hunters may only hunt deer in accordance with subd. par. 1.d.

2. Findings. The department shall, prior to making any modification for a deer management unit under subd.1., find that it is unlikely the deer population for the deer management unit will be reduced to within 20% of the overwinter population goal established in s. NR 10.104 under the established deer hunting rules. In making this determination, the department shall compare the deer harvest required to reduce the deer population to goal to the deer harvest likely to occur under the existing season structure.

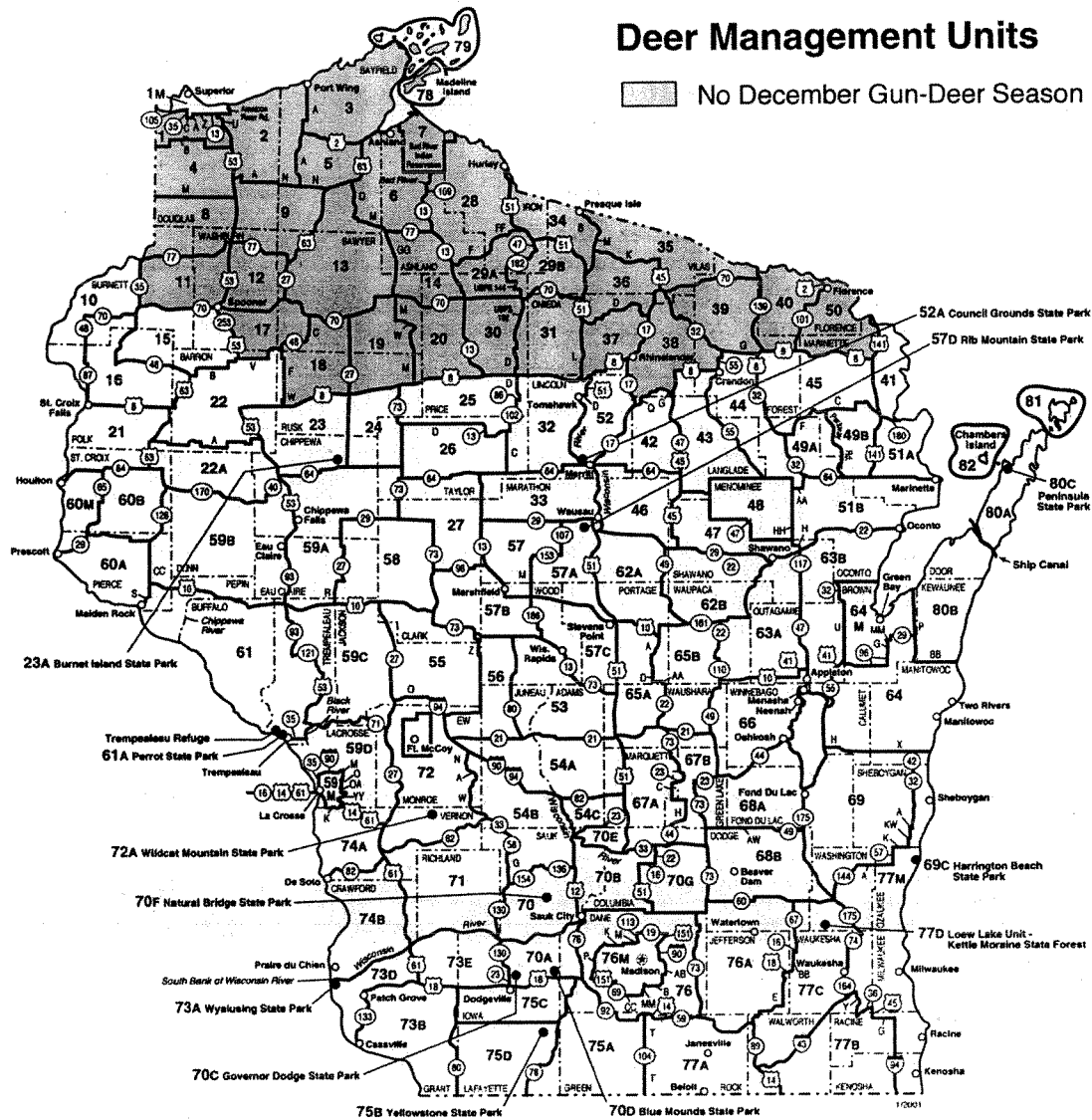
