

### REPORT ON THE STATUS OF BILINGUAL-BICULTURAL EDUCATION PROGRAMS IN WISCONSIN, CHAPTER 115, SUBCHAPTER VII, SECTION 115.996, OF THE WISCONSIN STATUTES

### **SCHOOL YEAR 1999-2000**

Under Section 115.996, Wisconsin Statutes, the state superintendent is required to annually report to the legislature on the status of bilingual-bicultural education programs funded under this authority. This report provides the specific information required by law for the 1999-2000 school year (paid during FY 2000).

Wisconsin school district personnel view Chapter 115, Subchapter VII, as very important. It provides funding for pupil populations whose language education needs would likely not be otherwise served sufficiently or equitably. Tim Boals, the department's bilingual/ESL education consultant, provided extensive telephone technical assistance, disseminated materials statewide, provided regional staff development activities, and conducted training for local bilingual/ESL program administrators. The legislature provided for 1.0 FTE in FY 2000. Tim Boals is the only state funded staff person for this program. He worked with federally funded (Title VII, IASA) program staff to revise instruments for gathering information needed for reporting to state and federal agencies. The Title VII program assistant is charged with fulfillment of the department's Title VII grant requirements, especially those for data collection, aggregation, analysis, publication, and dissemination.

### ACCOUNTABILITY: Major Focus of the 1999-2000 School Year

The department, with local partners, developed a framework for the academic assessment of limited-English proficient (LEP) pupils over the past three years. This was recently published in a CD-ROM format entitled *Wisconsin's Framework for Standards-Based Assessment of Limited-English Proficient Students*. The framework includes alternate performance indicators (APIs) in math, science, social studies, and language arts that are aligned with the Wisconsin Model Academic Standards. Use of the APIs allows LEP pupils to demonstrate their content area knowledge. The CD-ROM also contains a guide for the appropriate use of the APIs. Mr. Boals provided supervision for the production of the guide and is coordinating the ongoing regional training to build alternate assessment practice. Over 700 teachers serving LEP pupils have already participated in several one- and two-day training sessions. Standards-based alternate assessments assist bilingual and ESL educators in meeting federal accountability requirements, in aligning curriculum to high standards, and in improving feedback on pupil academic progress for local teachers and administrators.

The primary focus of the annual bilingual/ESL program administrators' meetings for the past two years has been to assist districts in creating an evaluation plan that will conclusively demonstrate the value of their programs. The evaluation plans developed will also indicate any areas of improvement that are needed. Districts are gathering data on the average length of time LEP pupils are served in bilingual/ESL programs before being classified as fully English proficient as well as how successful these pupils are once they are fully English proficient and no longer receive bilingual/ESL services. Per Title VII, these pupils are referred to as "reclassified." It is important to note that the term "reclassified" only refers to pupils who were limited-English proficient, but have been determined to be fully English proficient.

Within the next two years, the department plans to aggregate this information to create a better picture of how state funding is making a difference for LEP pupils. For example, the Sheboygan Area School District reports that it takes, on average, 5.5 years for LEP pupils to reach full English proficiency. Once these pupils are classified fully English proficient (i.e., "reclassified" per Title VII), their average performance on the grade 8 and 10 Wisconsin Knowledge and Concepts Examinations (WKCE) is actually above the performance of their monolingual English speaking peers – pupils who were never limited English proficient. This provides an outstanding indication of the quality of Sheboygan's ELL (English Language Learner) program in assisting these pupils become successful, contributing members of our society.

Another example is the Stevens Point Area School District which now has data contrasting the performance of LEP pupils who receive bilingual/ESL program support with those whose parents have opted them out of the ESL program. The district's data indicate that on the WKCE those pupils who receive program support outperform those who do not receive program support. It is the goal of the department's bilingual/ESL education program to have similar evidence from many more districts around Wisconsin within the next two to three years. This data will allow the department to compile reports supporting the value of these second language acquisition programs around the state.

In order to provide good programs, districts must be able to hire qualified teachers. The department's bilingual/ESL program staff have been working with local district and university staff to develop new teacher licensing standards (PI 34) for bilingual and English as a second language teachers that, if approved by the legislature, will take effect in 2004. These standards require that bilingual and ESL teachers be able to teach both language and academic content to LEP pupils. The standards require the knowledge, skills, and dispositions necessary to ensure that highly qualified teachers work with LEP pupils. The new standards encourage the elimination of college teacher education courses that do not directly address the needs of bilingual and ESL teachers working within Wisconsin's K-12 school environments.

One question often raised has to do with the appropriate length of time a pupil should be served in a bilingual/ESL program. The National Research Council (1997) summarizes research conducted over the past 30 years and confirms that it takes at least five to seven years for the average pupil to gain the cognitive academic skills in English to be able to equitably compete in an English-proficient classroom. During these five to seven years, a balanced approach that combines high quality content-based English as a second language instruction with some foundational support for the native language and culture is still overwhelmingly considered best practice by knowledgeable researchers and practioners. The research consensus is that high quality support and schoolwide understanding of the fundamental issues facing these pupils are absolutely essential for producing high-achieving pupils. Failure to provide adequate support results in frustrated pupils who do not succeed in, and who eventually drop out of, school and never achieve to their potential.

The state superintendent's finance taskforce, therefore, has recommended, as part of the biennial budget, an increase in state aid for this program from approximately 18% for the 1999-2000 school year reimbursement to 30%. This proposal would also assist smaller districts not currently eligible for state aid by allowing them up to a 30% reimbursement for the extra costs associated with providing special support for LEP pupils. [Note: these proposals were not included in the final budget passed by the legislature in July 2001.]

Mr. Boals will continue to annually identify priority tasks and issues to be addressed in the improvement of bilingual/ESL education programs. In cooperation with other department and

local district staff, he will develop strategies to achieve the goals necessary to address the issues of limited English proficiency and the underachievement of LEP pupils. Priority tasks at the local program level include aligning curriculum with state academic standards, improving content-based instructional methodologies, developing better pupil assessments, improving local program evaluation standards, improving teacher licensing standards, and reducing the gap in standardized test scores between LEP pupils and their English proficient peers.

The department continually seeks additional funding through federal grant opportunities. Grants are particularly beneficial for funding staff development initiatives and special projects. The program was awarded a Training for All Teachers grant from the US Department of Education, Office of Bilingual Education and Minority Languages Affairs (OBEMLA), in August 2000. This grant provides teacher professional development funding for the Milwaukee area and assists the statewide proficiency-based licensing initiative. Other such grants are pending approval.

### Languages/Program Locations

Of the 27,184 LEP pupils identified in Wisconsin, a total of 19,003 LEP pupils were served in state reimbursed programs in the following 38 Wisconsin school districts during the 1999-2000 school year:

Appleton, Beloit, DC Everest, Delavan-Darien, Eau Claire, Elkhorn, Fond du Lac, Franklin, Green Bay, Hortonville, Janesville, Kaukauna, Kenosha, LaCrosse, Lake Geneva J1, Lake Geneva-Genoa City, Madison, Manitowoc, Marshall, Menasha, Menomonie, Milwaukee, Neenah, New Berlin, Onalaska, Oshkosh, Racine, Sheboygan, Shorewood, Stevens Point, Superior, Two Rivers, Waukesha, Wausau, Wautoma, Whitewater, Whitnall, and Wisconsin Rapids.

Services provided to non-LEP pupils enrolled in programs offered in these school districts were not eligible for state aids under this authority. A non-LEP pupil is one whose dominant language is English or is a formerly LEP pupil who is now fully English proficient. In cases where non-LEP pupils are being taught in the same classroom as are eligible LEP pupils and by the same teacher whose salary/fringes are eligible for reimbursement, those salaries/fringes are prorated and reduced according to the percent of non-LEP pupils in the classroom.

The numerical distribution by language of those participating in a program for LEP pupils was: Hmong – 9,903; Spanish – 8,450; Khmer – 186; Lao – 178; Russian – 115; Tibetan – 84; Mandarin – 62; and Arabic – 25.

### Program Costs for the 38 Categorically Aided District Programs: Per Pupil Expenditures Analysis

For school year 1999-2000, 38 of the districts identifying LEP pupils met the criteria to receive categorical aids while 133 districts did not. In the 38 districts receiving categorical aids under ss.115.95-115.996, Stats., the overall total approved cost per LEP pupil was \$2,357, with an average state reimbursement of \$436 per LEP pupil. The approved costs per LEP pupil ranged from a low of \$383 per pupil to a high of \$5844. Thirty-two districts were in a per pupil expenditure band of \$1,110 to \$5,844; 15 districts were in a \$2,000 to \$3,000 band. In addition to variances in staff costs from district to district, other variables that affect the cost of a program include, but are not limited to:

- Small population vs. large population cost effectiveness;
- English-language proficiency level of pupils and range of proficiency levels among pupils in a classroom;
- amount of previous schooling of LEP pupils;
- staff/pupil ratio (both teacher/pupil and bilingual aide/pupil);
- amount of instructional contact time:
- instructional resources provided, e.g., texts, equipment, technology, native language materials/assessments;
- type of program, such as in-class vs. pull-out programs;
- cultural differences in learning; and.
- degree of parental involvement, which, for LEP pupils, includes providing a home environment rich in the native language, and outreach and services to LEP pupils, immigrant, or refugee families.

In the past, the appropriation from the state legislature was divided evenly among districts so that each received the same percentage of reimbursement for their approved expenditures. In 1999 Wisconsin Act 9, AB133 (the biennial budget) was passed, setting aside \$250,000 from the bilingual-bicultural appropriation of \$8,291,400. This set-aside is to be divided proportionally among school districts whose enrollments in the previous school year were at least 15% limited-English proficient pupils. The remainder of the appropriation (\$8,041,400) is divided evenly among all the districts according to their approved total budgets.

This year the only district qualifying for the set-aside aid is Wausau. The result of this change in distribution of the bilingual-bicultural appropriation is a reduction in actual reimbursement from 18.5125% to 17.9543% to the other 37 categorically aided districts; and a reimbursement of 24.5076% to Wausau.

In order to determine numbers of pupils potentially not served or underserved, program staff looked at the numbers of LEP pupils reported in the annual census (as required under s.115.96, Wis. Stats.) and compared these numbers to the numbers of LEP pupils served under the bilingual-bicultural statute.

In the Census of Limited-English Proficient Pupils for March 2000, 171 districts throughout the state identified a total of 27,184 enrolled LEP pupils. Of these, 19,003 were served in state reimbursed programs in 38 school districts. That leaves a balance of 8,181 LEP pupils during the 1999-2000 school year who should have also received services. They were enrolled in the 133 non-aided school districts or were LEP pupils not eligible for aid in the 38 aided districts. The data in the census report do not account for pupils arriving in districts between the March 1999 census and the following September (1999-2000 school year).

### Historical Profile: Fully English Proficient Pupils

The statistics presented below trace the history of bilingual education in Wisconsin from the 1980s to the present, in terms of numbers of pupils served in programs receiving categorical aid and numbers of pupils from these programs became fully English proficient during the school year reported. These pupils were previously referred to as "exited" pupils, but now are referred to by the Title VII term "reclassified." It is important to note that these terms describe only pupils who are no longer limited-English proficient and therefore no longer require bilingual or ESL program services.

Factors that account for the significant increase in the numbers of LEP pupils since the inception of the statute include, but are not limited to: continuous refugee intra-state and inter-state migration; a steady increase in the Spanish-proficient population; and an increase in the numbers of pre-school programs in the school districts.

The apparent decrease in the number of reclassified pupils, from time to time, is directly attributable to the increasing number of pupils who arrive at a pre-literate stage of learning. Working with pupils to prepare them to compete equitably in the classroom when they are not literate in their own language takes a longer period of time. Also attributable, are new and better evaluation procedures that result in decreasing numbers of reclassified pupils, but that give districts more concrete knowledge about their pupils and exactly where they are in the growth of their English language proficiency. In addition, many districts' inability to continue to provide summer programs due to lack of funds (e.g., spending caps and continually decreasing reimbursement) translates to additional years in bilingual-bicultural programs for many LEP pupils.
