RE: "Beating Drug Tests" A Fox 6 Investigation

Bob Segall of Fox 6 Milwaukee sent you a tape of an investigative report regarding the sale and use of "detoxifiers", or legal substances that help people pass drug tests. This Fox 6 investigation prompted Rep. Walker to introduce AB 425. AB 425 passed the Assembly on a voice vote on November 1, 2001 and is now in the Senate Committee on Judiciary, Consumer Affairs and Campaign Finance Reform. Mr. Segall hopes the committee will hold a hearing on the bill and vote it out of committee with a recommendation for passage. He says he is available if we have any questions or need more information.

The report followed the investigator as he went to several GNC, (General Nutrition Center) stores and asked the clerk about a product that would assist him in passing a drug test. Each time he was directed toward a variety of products that both the clerk and the labels promised would ensure a clean urine sample. Most of the products were kept behind the counter or in a locked cabinet because many high school students steal these products to pass school drug tests.

The report included an interview with a man who recently purchased and used one of these products. He claimed that many marijuana users he knew used these products and that they always work.

A drug test administrator was also interviewed. He claims that there is no common "herbal remedy" that flushes the system, rather it is the water that the user is instructed to drink along with the substance, that clears the system for a clean test. He said that this is a multi million-dollar industry that is preying on people's addictions. These detoxifiers have no other use.

WISCONSIN LEGISLATIVE COUNCIL AMENDMENT MEMO

2001 Assembly Bill 425

Assembly Amendment 1

2001 Assembly Bill 425 prohibits a person from manufacturing, advertising, selling, delivering, or possessing with intent to advertise, sell, or deliver any product (a masking agent) with the intent that it be used to produce a false negative drug test result. The bill also prohibits a person from using or possessing with intent to use a masking agent with the intent to produce a false negative drug test result.

Assembly Amendment 1 creates a specific definition of “masking agent,” rather than referring in the text of the prohibition to a product used to produce a false negative drug test result. Additionally, the definition of “masking agent” narrows the scope of the bill by limiting its application to masking agent products for which the “*primary use*” is to produce a false negative drug test result.

Passage of Assembly Bill 425, as amended by Assembly Amendment 1, was recommended by the Assembly Committee on Criminal Justice on a vote of Ayes, 10, Noes, 1.

Re: Ban on Detoxification Drugs

Dear Representative Walker:

We at General Medical Laboratories support the efforts to introduce the bill preventing the purchase, sale or manufacture of products used in the adulteration of drug tests. The availability of these products indirectly affects the general population since it has forced companies and laboratories to modify their procedures and increase the price of the drug tests.

As a SAMHSA accredited drug testing toxicology laboratory performing testing for rehabilitation programs and the medical establishment we have seen a dramatic increase in the use of adulteration products over the last few years. In order to prevent inadequate results from being reported to our clients we have implemented several testing procedures to identify samples that are adulterated, substituted and/or unsuitable for testing.


Even with this adulteration testing in place, the major problem is the continued availability of new adulterants in the market place. The laboratories can only test for those adulterants that are known. If a new adulterant is introduced into the market and the laboratory can not identify the specific component of the adulterant, then the sample has to be reported as unsuitable. This information does not help the employer because the actual source of the problem has not been identified.

Another effect of adulterants is the increase in the cost of the testing. Urine drug testing is a well established part of the DHHS administered program to fight drug use and abuse in the federal workplace. Other employers who are not under these federal regulations have also seen the need to test their employees or potential employees. A company which chooses not to test may be left with those persons unable to gain employment elsewhere. However, the companies that choose to test for drugs incur an extra expense to warranty the employees they hire are free of drugs.

Because of the problems caused by the sale of adulterants to the public and to better serve the community, we support the ban on these products from the market place.

Dear Mr. Walker:

I am delighted to learn that you are an advocate of Drug-Free Workplace Programs for Wisconsin businesses. Our Milwaukee based company, Substance Abuse Management, Inc. (SAMI) is the leading provider of Medical Review Officer and Third Party Administrator services to employers nationwide. Since founding the company in 1989, I have seen workplace drug testing grow tremendously so that today over 85 percent of all large employers include testing as part of their Drug Free Workplace Programs.

One of our physician Medical Review Officers, David Nahin, M.D. recently participated in a program presented by Channel 6, Milwaukee, on the topic of cheating on urine drug tests. As workplace drug testing has become more widespread in US companies, countless products and devices designed to subvert the drug testing process have been introduced in the marketplace. Most of these products are developed to adulterate the urine specimen by adding chemicals that mask illicit drug use or render the specimen unsuitable for testing. Inform the customer to return the old formula. If the customer received by Spectrum, a new bottle will be shipped.







Urine Luck™ works on all toxins, including alcohol and tobacco. These toxins are all organically based so the mechanism of Urine Luck™ with each toxin is similar, but not identical. It is undetectable, and contains no acids, Glutaredehyde, nitrites, or pyridine. The instructions state to urinate 1-2 times before the test because the first urination of the day has the

before the test, because the first urination of the day is the highest toxin level. It does not hurt to have a couple of 8oz glasses of water prior to the test. However, if the tester drinks too much water, the sample will be rejected for "too dilute", and Urine Luck™ is wasted.

Urine Luck™ has a 99.6% success rate at beating urinalysis if directions are followed. The directions are listed below which are also printed on the vial label.

● Directions

- 1 Urinate 1-2 times before test.
- 2 Simply add one vial of Urine Luck to 3-5 ounces (90-150 ml) of urine. Use half of vial for less than 3 ounces (90 ml) urine.
- 3 Do not use with other Detoxifying Products.
- 4 Do not drink more than 16 oz. of water an hour on the day of the test.
- 5 Mix slightly.
- 6 Do not take internally.
- 7 Avoid contact with skin, may cause irritation; flush affected area with large amounts of water.
- 8 Do not store in direct sunlight.

< There is an expiration date on the bottom left hand side label. The shelf life is two years. However, Spectrum changes the formula approximately every 6-9 months to stay ahead of the labs. If a certain formula stays on the market too long, the product is reverse-engineered by the labs and eventually becomes detectable. Older formulations can be exchanged for a current formulation free of charge. Inform the customer to return the old formula and once received by Spectrum, a new bottle will be shipped.

DETECTION of URINE LUCK™

Most of the older formulas of Urine Luck™ can be detected. Formulas 1.0 through 5.9 are detectable by the labs, however, these products have not been sold for years. If the product is detected, it will show up as high level of chrome, chromates, or chromium. The tester not following directions usually causes this. IF the entire bottle of Urine Luck™ is added to less than 3oz of urine, the chromate levels will be too high. Labs will often call the sample adulterated, presence of masking agent, or the a blocker. (see Section 8 - Adulterating Compounds)

With current formulations of Urine Luck™ 6.0 and higher the directions state, "to add contents of vial to 3-5 ounces (90-150 ml) of urine, for samples less than 3 ounces add half the vial." IF an individual fails to follow directions and adds the entire vial of Urine Luck™ to 1-2 ounces of urine the sample will be rejected as adulterated because the pH will be less than 3.0 or too acidic.
