Two offices are in Milwaukee County and three are in Waukesha County. We do about 900 transactions each year with total sales of about 120 million dollars. Most of our transactions are single family homes. I am also an officer of K-B of Waukesha, Inc., a Wisconsin Corporation which is involved in land development and real estate investments.

1998-present: Appointed to the Real Estate Board by Governor Thompson.

1995-96: Served as President of the Wisconsin Realtors Association. Prior to that I held a number of volunteer positions within the Realtor organization, including being a Director of both the Wisconsin Realtors Association and the National Association of Realtors.

I obtained my Real Estate Broker's license in 1973 and worked at Zitzke Realty in Wauwatosa, Smart Realty in Waukesha and Hardy and Co. Realtors in Waukesha prior to opening Bethesda Real Estate.

Prior to starting in real estate, I worked for Chicago Bridge & Iron in Illinois and Amron Corporation in Waukesha, WI.

I graduated from Mayville High School in 1960 and attended UW-Oshkosh and several other colleges in Wisconsin and Illinois. I did not obtain a degree.

1964-71 I joined the Wisconsin National Guard (32nd Division) and was transferred to an Army Reserve in Illinois after accepting an employment opportunity in Chicago. I finished my obligation with an Army Reserve unit in Milwaukee after returning to Wisconsin in 1970.


