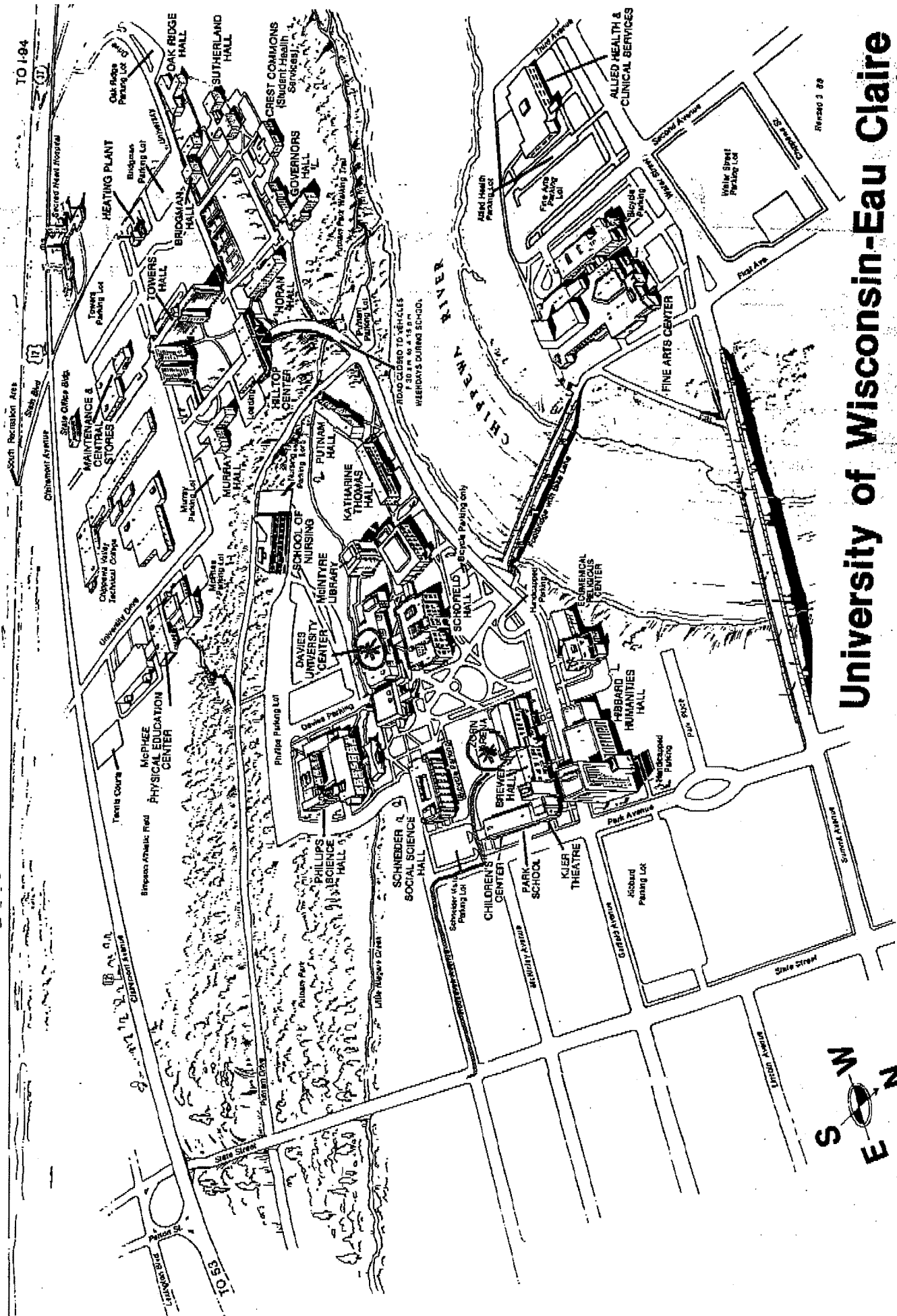
Parking for the general public can be found in the guest parking lot outside of the Schneider Social Science Hall or in the Water Street parking lot located on the north side of campus.

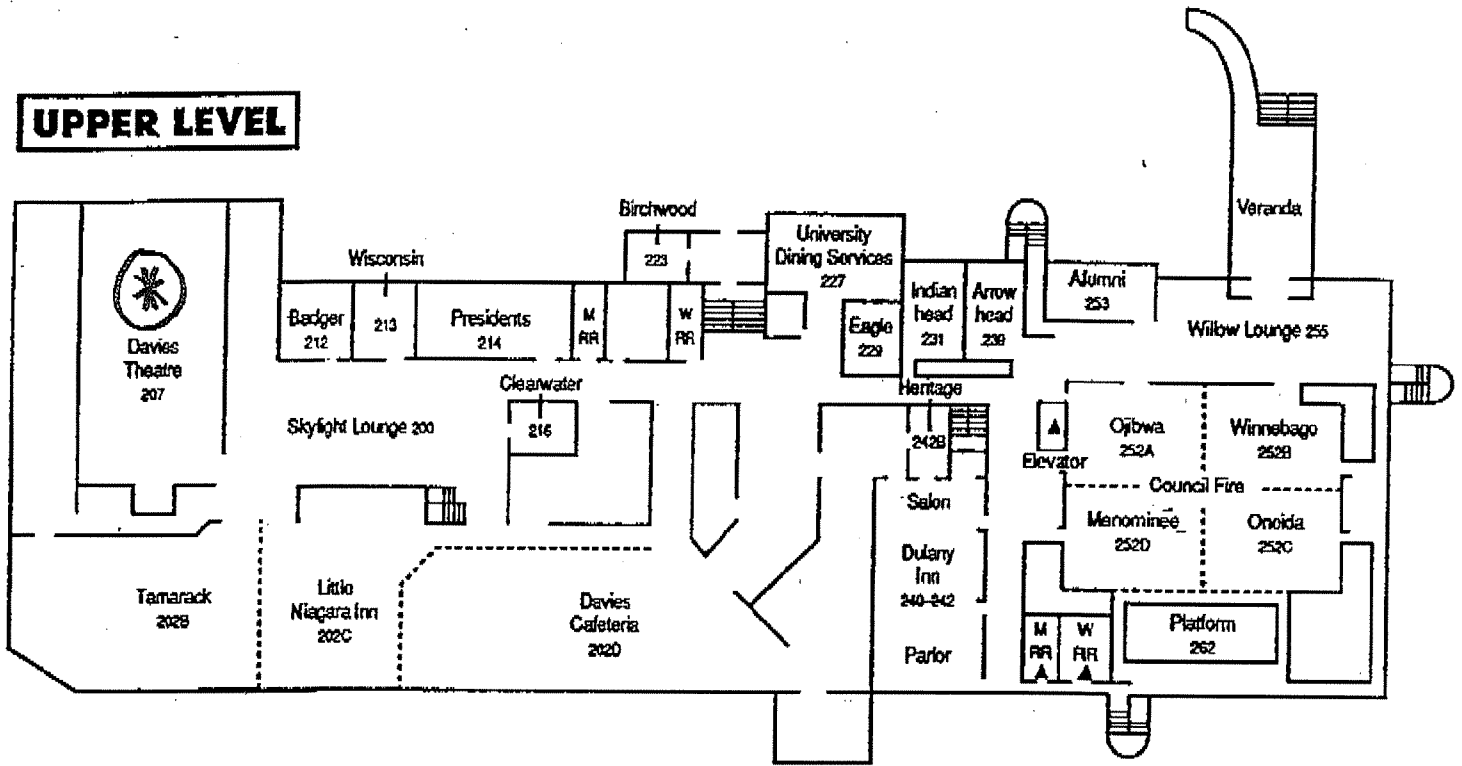

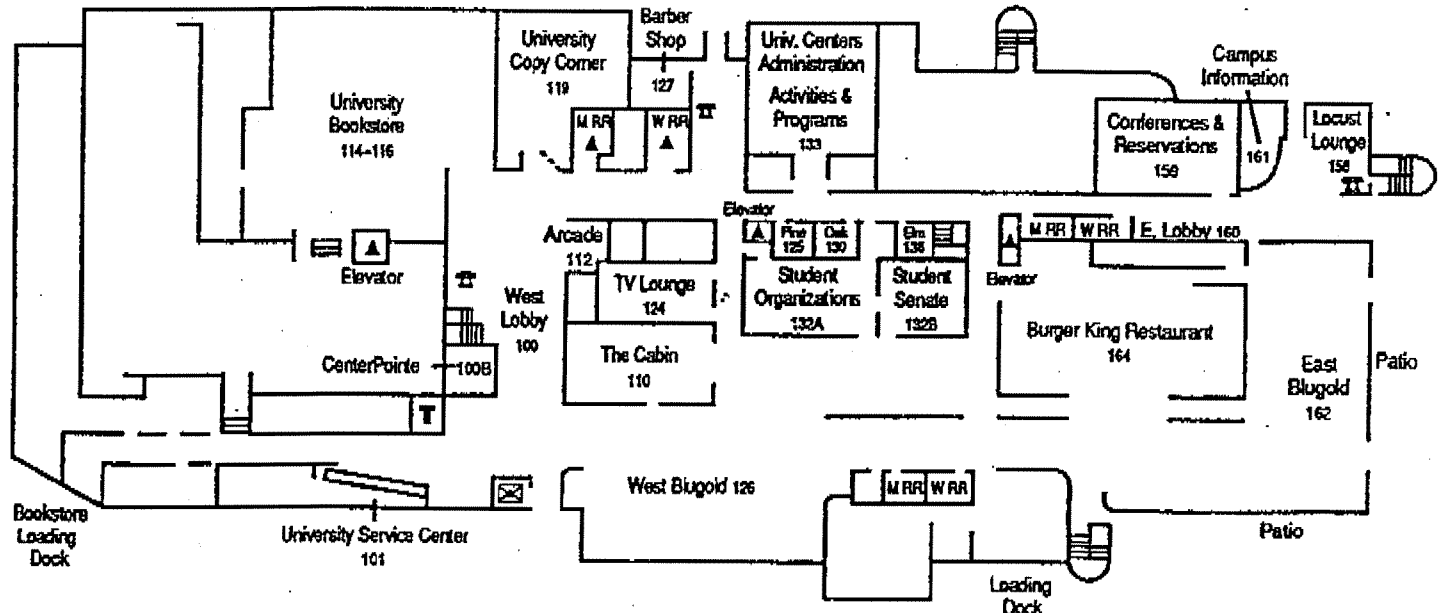

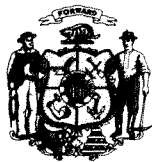
