



**SENATE AMENDMENT 2,
TO SENATE SUBSTITUTE AMENDMENT 1,
TO 2003 SENATE BILL 180**

June 4, 2003 – Offered by Senator COWLES.

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page 1, line 5: after “utilities” insert “and making an appropriation”.

3 **2.** Page 1, line 6: before that line insert:

4 “**SECTION 1b.** 20.835 (1) (d) of the statutes is amended to read:

5 20.835 (1) (d) *Shared revenue account.* A sum sufficient to meet the
6 requirements of the shared revenue account established under s. 79.01 (2) to provide
7 for the distributions from the shared revenue account to counties, towns, villages and
8 cities under ss. 79.03, 79.04 (1) to (4) and 79.06.

9 **SECTION 1d.** 20.835 (1) (dm) of the statutes is created to read:

10 20.835 (1) (dm) *Public utility distribution account.* Beginning in 2005, a sum
11 sufficient to make the payments under s. 79.04 (5), (6), and (7).”.

12 **3.** Page 1, line 6: delete “**SECTION 1**” and substitute “**SECTION 1m**”.

1 **4.** Page 2, line 24: after that line insert:

2 “(d) Replacing steam generating equipment at a combustion-based renewable
3 facility, as defined in s. 196.378 (1) (g), to increase efficiency or capacity, if the facility
4 remains a combustion-based renewable facility, as defined in s. 196.378 (1) (g), after
5 replacing the equipment.

6 **SECTION 7m.** 79.01 (2m) of the statutes is created to read:

7 79.01 **(2m)** There is established an account in the general fund entitled the
8 “Public Utility Distribution Account,” referred to in this chapter as the “public utility
9 account.” There shall be appropriated to the public utility account the sums specified
10 in s. 79.04 (5), (6), and (7).”

11 **5.** Page 8, line 9: delete “shared” and substitute “public utility”.

12 **6.** Page 8, line 10: delete “revenue”.

13 **7.** Page 8, line 25: delete “shared revenue” and substitute “public utility”.

14 **8.** Page 9, line 14: delete “shared revenue” and substitute “public utility”.

15 **9.** Page 11, line 7: on lines 7, 14 and 21, delete “shared revenue” and substitute
16 “public utility”.

17 **10.** Page 12, line 24: delete “June 1” and substitute “June 10”.

18 **11.** Page 13, line 2: after “sections” insert “20.835 (1d) and (dm),”.

19 **12.** Page 13, line 2: after “(4)” insert “, 79.01 (2m),”.
