TO ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO 2003 ASSEMBLY BILL 67

1 At the locations indicated, amend the substitute amendment as follows:

2 1. Page 3, line 2: before the colon insert “, unless the employee or prospective
3 employee does not apply the refusal in the same manner to all patients and
4 prospective patients”.

5 2. Page 5, line 16: delete “No hospital” and substitute “No Except as provided
6 in sub. (4m), no hospital”.

7 3. Page 5, line 18: delete (lines 18 and 19) and substitute procedure or removing
8 a human embryo or fetus. A any of the following:”

9 ¶ (b) Except as provided in sub. (4m), a physician or any other person who is a
10 member of or associated with the”.

11 4. Page 6, line 1: delete “(c) A physician” and substitute “(c) Except as
12 provided in sub. (4m), a physician”.

1 **5.** Page 7, line 17: delete “No A hospital” and substitute “No Except as
2 provided in sub. (4m), a hospital”.

3 **6.** Page 7, line 23: delete “No hospital” and substitute “No Except as provided
4 in sub. (4m), no hospital”.

5 **7.** Page 8, line 23: after that line insert:

6 “**SECTION 14m.** 253.09 (4m) of the statutes is created to read:

7 253.09 (**4m**) (a) Subsections (1r) (b) and (c), (2), and (3) do not apply unless a
8 physician, employee, or other person who refuses to participate in an activity
9 specified in sub. (1r) (a) 1. to 8. makes the same refusal with respect to all patients
10 and prospective patients.

11 (b) Subsection (1r) (a) does not apply unless a hospital that refuses to admit a
12 patient or allow the use of the hospital facilities for a patient for the purpose of
13 performing ~~anything~~ specified in sub. (1r) (a) 1 to 8. makes the same refusal for all
14 patients and prospective patients.”. *any activity*

15 **8.** Page 9, line 14: delete “No A person” and substitute “No Except as provided
16 in sub. (9), a person”.

17 **9.** Page 11, line 6: delete “A person” and substitute “Except as provided in sub.
18 (9), a person”.

19 **10.** Page 11, line 22: after that line insert:

20 “**SECTION 21m.** 441.06 (9) of the statutes is created to read:

21 441.06 (**9**) Subsections (6) (b) and (7) do not apply to a person licensed as a
22 registered nurse under this section or as a practical nurse under s. 441.10 unless he
23 or she makes the same refusal for all patients and prospective patients.”.
