

TO 2003 ASSEMBLY BILL 462**

1 At the locations indicated, amend the bill as follows:

2 1. Page 1, line 3: after "licenses" insert "and providing a penalty".

3 2. Page 2, line 8: after that line insert:

4 "SECTION 2m. 343.07 (7) of the statutes is created to read:

5 343.07 (7) PENALTY FOR CERTAIN VIOLATIONS. Notwithstanding s. 343.43 (1) (d)
6 and (3m), any person who violates sub. (1) (dm) or sub. (4) (b) 3. shall be required to
7 forfeit \$50 for the first offense and not less than \$50 nor more than \$100 for each
8 subsequent offense."

10 "SECTION 3m. 343.085 (6) of the statutes is created to read:
