.....Hello. Just wanted to point something out regarding the two bills on the income tax exemption for national guard and reservist pay.

You may want to consider language in both AB 155 and AB 807 that would prevent an individual from claiming the current armed forces member tax credit and the proposed military pay exemption with the same income. The language in the current armed forces member tax credit could be amended as follows:

Section 1. 71.07(6m)(c)4 of the statutes is created to read:

71.07(6m)(c)4. Persons who claim the subtraction under sec. 71.05(6)(b)34 are not eligible for the credit under this subsection.
