**The Assembly Committee on Public Health voted to introduce an amendment to AB 919 that would contain the following items:**

- 1. The definition of "health care provider" on page 3, line 3, would be expanded to include licensed podiatrists, dentists, and veterinarians.**
- 2. On page 3, line 14, "893.82" would replace "893.82(3)", thereby clarifying that the liability limit in sub. (6) would apply to these volunteers. After I spoke with you earlier, I noticed that SECTION 12 of the bill includes them, so the amendment will just reconcile the conflict between the 2 provisions (and be consistent with the bill's analysis and fiscal estimate).**

**The amendment should be sent to Carolyn Hughes in Rep. Hines' office. I think they would like to report the bill out fairly quickly.**
