3 "SECTION ~~11~~. Assembly rule 11m is created to read:

4 ASSEMBLY RULE 11m. **Committees of conference.** If a committee of

5 conference, or a successor committee of conference, has not submitted a report within

6 30 days after the appointment of the committee, the committee of conference is

7 dissolved. If so dissolved, another committee of conference consisting of members

8 who have not served on the committee of conference or a successor committee of

9 conference shall be appointed within 5 days as provided under the rules of the senate

10 and assembly for the initial appointments and may proceed to further consideration

11 of the proposal or of amendments thereto."
