1 **Relating to:** honoring the life and public service of Ecologist Forest W. Stearns upon  
2 his induction into the Wisconsin Conservation Hall of Fame.

3 Whereas, Forest W. Stearns was born on September 18, 1918, in Shorewood,  
4 Wisconsin; and

5 Whereas, Forest Stearns received his undergraduate degree from Harvard  
6 University and continued his education at the University of Wisconsin-Madison,  
7 where he received his <sup>2</sup> Masters and doctorate <sup>e</sup> doctoral degrees; and

8 Whereas, Forest Stearns was an expert on plant life in the Lakes State <sup>S</sup> Region  
9 and is an internationally renowned and respected ecologist; and

10 Whereas, Forest Stearns served as a mentor to students as a professor of biology  
11 at Purdue University from 1947 to 1957 and as a faculty member and department  
12 chair in botany and biology at the University of Wisconsin-Milwaukee from 1968 to  
13 1987, where he was among the nation's pioneers in the emerging field of urban  
14 ecology; and
