Kelly! I have checked the statutes and have found the following. Sec. 84.1025, Stats., names USH 14 the Frank Lloyd Wright Memorial Highway commencing at Richland Center and proceeding easterly to Madison.

Sec. 84.103(1t), Stats., names USH 14 the Purple Heart Memorial Highway commencing at the Wis. - Minn., border and proceeding easterly to Richland Center.

2003 SB-40, proposes to name USH 14 commencing at the Wis. - Ill., border and proceeding westerly to Richland Center as the Ronald Reagan Highway.

It appears that USH 14 from Wis. - Ill., border to Madison is not yet named. If, however, SB-40 passes as is it appears USH 14 from Madison to Richland Center would be designated as both the Frank Lloyd Wright and the Ronald Reagan Highway. SB-40 contains no language repealing the Frank Lloyd Wright designation, thus the likely outcome could be confusion in having that portion of USH 14 named both the Frank Lloyd Wright Memorial Highway and the Ronald Reagan Highway.
