Hello Rick--

As Sen. Carpenter told you, we need the following the amendments drafted ASAP. We were giving notice of this LRB this morning. If you have any questions or comments please don't hesitate to give me a call.

Proposed Amendment re Gaming Compacts Bill

1. Change the effective date to July 1, 2003 (beginning of new biennium).
2. Legislature must disapprove of proposed negotiated compact by supermajority.
3. If the legislature does not approve the compact, without change, the legislature shall recommend changes and send them to the governor, who may renegotiate with the tribe, or enter into the compact as originally negotiated.
4. Legislature must disapprove of the proposed negotiated compact within 7 days of governor's submission of proposed compact to the legislature.
5. Question of whether compact is detrimental to community must be determined by a majority vote of the directly affected municipality, after a 90 day period of notification with public hearings
6. The required Joint Resolution regarding whether compact is detrimental to the surrounding community must be passed by a supermajority.
