Thanks for the quick work on the amendments. Here are some more. Call me if you have questions.

- Delete the last 3 words of pg. 2 line 8
- Delete words "or renew", and except from the law any compacts that the governor deems to be permanent or non-renewable.

SENATE AMENDMENT,

**TO 2003 SENATE BILL (LRB-2100/1)** 

At the locations indicated, amend the bill as follows:

1. Page 2, line 10: after "renegotiation" insert "and the legislature shall notify the governor of the topics that need to be included in the renegotiated compacts, including, specifically, any topics related to coverage under the worker's compensation program and collective bargaining rights for individuals employed at Indian gaming casinos. The governor shall include in any renegotiated compact all of the topics specified by the legislature."
