Thanks for the quick work on the amendments. Here are some more. Call me if you have questions.

- Delete the last 3 words of pg. 2 line 8
- Delete words "or renew", and except from the law any compacts that the governor deems to be permanent or non-renewable.
- Legislature, in their review disapproval of the compact, will be allowed require that scope of the compacts be broadened or expanded to include specific topics, including but not limited to the workers' compensation or collective bargaining issues.

5 ✓3. Page 2, line 6: after "(1)," insert "other than a compact that is permanent  
6 or nonrenewable,".

7 ✓4. Page 2, line 7: delete "extend, or renew" and substitute "or extend".

8 ✓5. Page 2, line 13: delete "extended, or renewed" and substitute "or extended".
