12	committee on tribal gaming compacts. If the committee approves the compact, it

shall submit the proposed compact to the legislature for approval. If the committee

2	the compact to the governor for renegotiation. Neither the senate or assembly may
3	consider a proposed compact until a committee of that house has held a public
4	hearing regarding the compact in all counties in which a casino affected by the
5	compact is located.
