



SENATE AMENDMENT,  
41  
TO 2003 SENATE BILL (~~LRB-2100/1~~)

1 At the locations indicated, amend the bill as follows:

2 1. Page 2, line 3: after that line insert:

3 "SECTION 1m. 14.035 (1m)<sup>√</sup> of the statutes is created to read:

4 14.035 (1m) There is created the joint committee on tribal gaming compacts  
5 consisting of an equal number of members of the senate and <sup>the</sup> assembly and an equal  
6 number of members of the majority party and the minority party in the senate <sup>and</sup> in the  
7 assembly, appointed as are the members of standing committees in the respective  
8 houses. Only members who represent a district in which is located a casino operated  
9 under a compact entered into under <sup>this section</sup> ~~§ 14.035~~ may serve as a member of the  
10 committee."

11 2. Page 2, line 7: delete "legislature for approval." and substitute "<sup>to the</sup> joint  
12 committee on tribal gaming compacts. If the committee approves the compact, it  
13 shall submit the proposed compact to the legislature for approval. If the committee

1 does not approve without change the proposed compact, the committee shall return  
2 the compact to the governor for renegotiation. Neither the senate or assembly may  
3 consider a proposed compact until a committee of that house has held a public  
4 hearing regarding the compact in all counties in which a casino affected by the  
5 compact is located".
