


At the locations indicated, amend the bill as follows:

1. Page 2, line 10: delete "Not" and substitute "If the testimony is given in a case other than a criminal case or a case brought under ch. 980, not".

2. Page 2, line 14: after "If" insert "the testimony is given in a case other than a criminal case or a case brought under ch. 980 and if".

3. Page 3, line 6: after "admitted" insert "under sub. (1)".

4. Page 3, line 8: after that line insert:

"SECTION 5m. 907.02 (3) of the statutes is created to read:

907.02 (3) If the testimony is given in ~~a case other than~~ a criminal case or a case brought under ch. 980 and if scientific, technical, or other specialized knowledge will assist the trier of fact to understand the evidence or to determine a fact in issue, a

1 witness qualified as an expert by knowledge, skill, experience, training, or education
2 may testify thereto in the form of an opinion or otherwise." ✓

3 5. Page 3, line 15: delete "Facts" and substitute "Unless the testimony is given
4 in a criminal case or a case that is brought under ch. 980, facts". ✓
