Please draft identical amendments to ASA 1 to AB 201 and to the sub. to SB 82 to do the following:

- On p. 9, lines 2-3 and on p. 12, lines 24-25, return the time limit language to current law (i.e., as soon as possible).
- On p. 21, line 22, add language requiring that the decision be made within 30 days.
- On p. 33, line 19, delete "2004" and substitute "2005".

SENATE AMENDMENT,
TO SENATE SUBSTITUTE AMENDMENT (LRBs0379/2),
TO 2003 SENATE BILL 82

1 At the locations indicated, amend the substitute amendment as follows:

2 1. Page 9, line 2: delete lines 2 and 3 and substitute "hearing. The
3 department shall render its decision as soon as possible after the hearing and shall
4 send".

5 2. Page 12, line 24: delete lines 24 and 25 and substitute "hearing. The
6 department shall render its decision as soon as possible after the hearing and shall
7 send".

8 3. Page 21, line 22: after "child" insert "and shall render a decision no later
9 than 30 days after receipt of the request for review under subd. 1".

10 4. Page 33, line 19: delete "2004" and substitute "2005".
