895.35(2) Notwithstanding sub. (1), the city, town, village, school district, technical college district, or county shall pay all reasonable expenses under sub. (1) for an emergency medical services technician under s. 146.50 (1) (e) or (hm), a fire fighter, or a law enforcement or correctional officer, unless, in relation to the charges or action resulting in expenses under sub. (1), any of the following ~~apply~~ applies:
