SENATE AMENDMENT. TO SENATE SUBSTITUTE AMENDMENT 2, TO 2003 SENATE BILL 180



At the locations indicated, amend the substitute amendment as follows: 1

- **1.** Page 12, line 3: after "(b)" insert "1.".
- **2.** Page 12, line 9: after that line insert:
- "2. If a baseload electric generating facility as described in subd. 1. is located on a site that is contiguous to a municipality in which the facility is not located, the contiguous municipality shall receive annually from the public utility account a payment in an amount that is equal to the number of megawatts that represents the production plant's name-plate capacity, multiplied by \$100.\frac{1}{3}.
