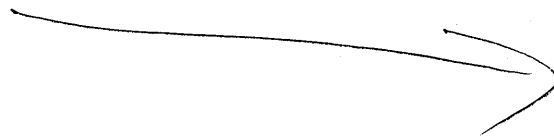

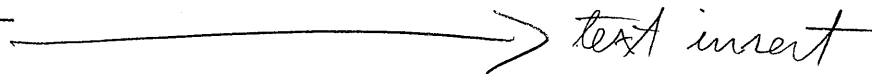

Under current law, a local professional baseball ^{ss} park (district) district may collect sales and use taxes from the sale of tangible personal property and taxable services in the district. The district may ^{not} collect ^{such} taxes after the calendar quarter in which the district certifies to the department of revenue that the district has retired all ^{of} its bonds. Under ^{this bill} this bill, the district may not collect sales and use taxes in the district after the calendar quarter ending on December 31, 2014.
