- 4 2. Page 10, line 6: delete "to which" and substitute "if".
- 5 3. Page 10, line 9: delete lines 9 to 12 and substitute:
- 6 "2. The state is listed in the rule promulgated by the department of justice
- 7 under s. 165.25 (11)".
- 8 4. Page 10, line 14: delete that line and substitute "who is not a Wisconsin
- 9 resident, who has been issued an out-of-state authorization, and who is not
- 10 prohibited from".
- 11 5. Page 42, line 4: delete "to a licensee".

1           **6.** Page 42, line 5: after “class” insert “if the course or class is one described in  
2 sub. (3) (h)”.
