2 weapon or storing it in the motor vehicle.

3 c. The individual is traveling directly to any person's private property from his  
4 or her place of employment or business, from any person's private property, or from  
5 a place that is not within 1,000 feet from the grounds of the health care facility, as  
6 defined in s. 150.84 (2).

7 d. The individual is traveling directly to his or her place of employment or  
8 business from another place of his or her employment or business, from any person's  
9 private property, or from a place that is not within 1,000 feet from the grounds of the  
10 health care facility, as defined in s. 150.84 (2).

11 e. The individual is traveling directly to a place that is not within 1,000 feet  
12 from the grounds of the health care facility, as defined in s. 150.84 (2), from another  
13 place that is not within 1,000 feet from the grounds of the health care facility, as  
14 defined in s. 150.84 (2), from any individual's private property, or from his or her  
15 place of employment or business.

16 f. The individual's possession of the handgun is described in s. 948.605 (2) (b).
