3 "3m. A group home or a residential care center for children and youth."

Page 38, line 5: after that line insert:

"(ar) notwithstanding par. (a) 3m., the authorized representative of a group home ^{or} a residential care center for children and youth may permit a licensee or out-of-state licensee to carry a concealed weapon in the home ^{or} center if the authorized representative gives written notice to the parents or guardians of the individuals placed ^{in the home or center} and to the ^{court} court that placed the individuals in the home or center."
