SENATE AMENDMENT,  
TO SENATE SUBSTITUTE AMENDMENT (LRBs0226/1),  
TO 2003 SENATE BILL 214

1 At the locations indicated, amend the substitute amendment as follows:

2 1. Page <sup>2</sup>4, line <sup>2</sup>10: delete "and providing penalties" and substitute "providing  
3 penalties, and making an appropriation".

4 2. Page <sup>2</sup>15, line <sup>3</sup>11: before that line insert:

5 "SECTION 1c. 20.455 (2) (bx) of the statutes is created to read:

6 20.455 (2) (bx) *Reimbursement of certain costs incurred by counties in licensing*  
7 *the carrying of a concealed weapon.* A sum sufficient to pay counties the costs  
8 certified under s. 175.50 (19m)."

9 3. Page <sup>2</sup>17, line <sup>3</sup>11: delete "SECTION 1c" and substitute "SECTION 1m".

10 4. Page <sup>40</sup>34, line <sup>12</sup>2: after that line insert:

11 "(19m) REIMBURSEMENT OF CERTAIN COUNTY COSTS. Annually, any county that has  
12 incurred costs relating to the issuance or renewal of licenses under this section shall

1 certify to the department of justice the amount of those costs that are not covered by  
2 any fees paid to the county under s. 175.50 (7) (bd), (13), and (15) (b) 4. a. No later  
3 than 60 days after receiving the certification, the department of justice shall  
4 reimburse the county for the certified costs.”
