1 At the locations indicated, amend the substitute amendment as follows:

2 1. Page ~~31~~³⁸, line ~~29~~²: after that line insert:

3 "~~10~~¹⁶ A privately owned building, unless the owner of the building has consented
4 to the carrying of the concealed weapon or has posted a sign at an entrance to the
5 building indicating that carrying a concealed weapon is permitted in the building."
