ORIGINAL REQUEST:

Require applicants that have a disability for which benefits are paid by the state or federal governments to divulge the nature of their disability on the application form. Someone who has been diagnosed with post-traumatic stress disorder, and still has the disorder as evidenced by disability payments, should not be carrying a concealed weapon. If the state and federal government is paying disability payments, then one can assume that there was some sort of official hearing held that made a determination that such a disability exists. (Provide that this information not be public record).

PLEASE ADD:

Any discharge for psychological or emotion problems, provide copy of discharge and sign a release to allow the sheriff to verify the reason for discharge.
