TO SENATE SUBSTITUTE AMENDMENT 2,
TO 2003 SENATE BILL 214

1 At the locations indicated, amend the substitute amendment as follows:

2 1. Page 19, line 25: delete that line and substitute:

3 “(h) The individual has successfully completed a firearm training or firearm
4 safety course or class that is offered by a state or local government agency and that
5 meets the requirements of sub. (4m).”.

6 2. Page 20, line 1: delete lines 1 to 21.
