- 9 1. An electric weapon, as defined in s. 941.295 (4).

- 11 3. A knife other than a switchblade knife under s. 941.24.
- 12 4. A billy club.
- 5. A handgun that is a revolver, but only if the firing chamber under the hammer is empty.
- 6. A handgun other than a revolver, but only if its firing chamber is empty.".

- 17 1. He".
- **8.** Page 38, line 8: delete "(b), and one" and substitute "(b).
- 2. If concealed, the handgun meets the requirements of s. 175.50 (1) (j) 5. and
- 20 6.
- 21 3. One".
- **9.** Page 38, line 10: delete "1." and substitute "a.".
- **10.** Page 38, line 11: delete "2." and substitute "b.".

- **11.** Page 38, line 13: delete "3." and substitute "c.".
- 2 **12.** Page 38, line 16: delete "4." and substitute "d.".
- 3 **13.** Page 38, line 19: delete "5." and substitute "e.".
- 4 **14.** Page 38, line 22: delete "6." and substitute "f.".
- 5 **15.** Page 47, line 14: after "weapon" insert "or unless the weapon is a handgun,
- as defined in s. 175.50 (1) (bm), that does not meet the requirements of s. 175.50 (1)
- 7 (j) 5. and 6".
- **16.** Page 48, line 7: after "175.50 (1) (bm)." insert "This paragraph does not
- apply if the firearm is concealed without the requirements of s. 175.50 (1) (j) 5. and
- 10 6. being met.".
- 11 **17.** Page 52, line 7: delete ", as".
- **18.** Page 52, line 8: delete "defined in s. 175.50 (1) (j), other than a handgun,
- as defined in s. 175.50 (1) (bm)," and substitute "described in s. 175.50 (1) (j) 1. to 4.".
