1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** Page ~~9~~⁸, line ~~22~~²³: after "(2g) (b)" insert "and (cm)". ✓

3 **2.** Page ~~13~~¹², line ~~17~~²³: after that line insert: ✓

4 "(cm) If he or she is going armed with a concealed handgun, a licensee or an
5 out-of-state licensee shall carry a device to lock and secure the handgun."

6 **3.** Page ~~32~~³⁹, line ~~19~~¹¹: after that line insert:

7 "(dm) If a licensee or an out-of-state licensee is carrying a handgun, he or she
8 shall lock and secure the handgun if he or she leaves it unattended in a motor vehicle
9 or at another location." ✓

10 **4.** Page ~~32~~³⁹, line ~~20~~¹²: delete "(b) or (c)" and substitute "(b), (c), or (cm)". ✓
