SENATE AMENDMENT,
TO SENATE SUBSTITUTE AMENDMENT 1,
TO 2003 SENATE BILL 214

1 At the locations indicated, amend the substitute amendment as follows:

2 ✓ 1. Page ~~8~~⁸, line ~~24~~²²: after that line insert:

3 “(ae) “Brandish” means to intentionally remove a concealed weapon from a
4 holster or sheath in the presence of another individual, regardless of whether the
5 weapon remains concealed, or to intentionally engage in any action that makes a
6 concealed weapon clearly visible to another individual.”.

7 ✓ 2. Page 9, line ~~29~~¹: after that line insert:

8 “(ak) “Display,” with respect to a license issued under this section or an
9 out-of-state authorization, includes permitting the person to whom the license or
10 out-of-state authorization is displayed to write down the name and the license or
11 permit number that are on the license or out-of-state authorization.”.

12 ✓ 3. Page 12, line ~~24~~¹³: before “A CONCEALED” insert “OR BRANDISHING”.

✓ 4. Page ~~18~~¹², line ~~17~~²³: after that line insert:

“(d) If a licensee or an out-of-state licensee brandishes a concealed weapon that he or she is carrying, the licensee or out-of-state licensee shall display his or her license or out-of-state authorization to any person present, upon that person’s request.”.

✓ 5. Page ~~22~~³⁹, line ~~21~~¹³: after that line insert:

“(am) A licensee or an out-of-state licensee who intentionally violates sub. (2g) (d) may be fined not more than \$1,000 or imprisoned for not more than 90 days or both.”.
