TO SENATE SUBSTITUTE AMENDMENT (LRBs0161/3),  
TO 2003 SENATE BILL 214**

#. Page 23, line 6:  
substitute "paragraph"  
for "subsection".

1 At the locations indicated, amend the substitute amendment as follows:

2 ✓ 1. Page 18, line 1: after "FORMS." insert "(a)".

3 ✓ 2. Page 18, line 14: delete "(e)" and substitute "1.".

4 ✓ 3. Page 18, line 16: delete "(f)" and substitute "2.".

5 ✓ 4. Page 18, line 19: delete "(g)" and substitute "3.".

6 ✓ 5. Page 18, line 22: delete "(h)" and substitute "4.".

7 ✓ 6. Page 19, line 1: delete "(i)" and substitute "5.".

8 ✓ 7. Page 19, line 2: after that line insert:

9 "(bm) The department shall design a prescription drug-information form for  
10 individuals who apply for a license under this section to have completed by a  
11 physician, as defined in s. 448.01 (5). The department shall complete the design of

1 the form no later than the design of the application form under par. (a). The  
2 department shall distribute the forms to any sheriff who issues licenses under sub.  
3 (2) (a) or (c) for distribution to applicants. The form shall request all of the following:

4 1. The name and signature of the physician.

5 2. A list of any prescription drugs that the applicant takes on a regular basis.

6 3. A physician statement outlining interactions that the prescription drugs on  
7 the list in subd. 2. could have when taken with any other prescription drug on the  
8 list in subd. 2. or with any common nonprescription drug product, as defined in s.  
9 450.01 (13m).

10 4. A physician statement as to whether the list in subd. 2. contains any  
11 prescription drug that could prevent him or her from safely handling a handgun or  
12 that is prescribed for any mental illness or for a physical illness that could prevent  
13 him or her from safely handling a handgun.”.

14 ✓ 8. Page 19, line 20: after that line insert:

15 “(fm) The completed form described in sub. (5) (bm).”.

16 ✓ 9. Page 25, line 7: after “(a)” insert “or (cm)”.

17 ✓ 10. Page 27, line 7: after that line insert:

18 “(cm) If a licensee is prescribed a prescription drug that is not on his or her list

19 under sub. (5) (dm) 2., the licensee shall have a physician update the form under sub.

20 (7) (fm).”

21 ✓ 11. Page 32, line 19: after that line insert:

22 “(dm) 1. A licensee to whom sub. (12) (cm) applies may not carry a concealed  
23 weapon until he or she has a physician update the information under sub. (7) (fm).”

1           2. A licensee to whom sub. (12) (cm) applies does not have a valid license with  
2       respect to ss. 23.33 (3) (e), 29.089 (2), 29.091 (2), 29.621 (4) (b), 167.31 (4) (ar), 941.235  
3       (2) (d), 941.237 (3) (ct), 941.295 (2) (g), 948.605 (2) (c), and 948.61 (3m) until he or she  
4       has a physician update the information under sub. (7) (fm).”.

5       ✓**12.** Page <sup>39</sup>~~33~~, line <sup>21</sup>~~4~~: after that line insert:

6           “(dg) A licensee who intentionally violates sub. (12) (cm) or (16) (dm) shall be  
7       fined not more than \$100.”.
