

**SENATE AMENDMENT ,
TO SENATE SUBSTITUTE AMENDMENT (LRBs 0161/3),
TO 2003 SENATE BILL 214**

0226/1

At the locations indicated, amend the substitute amendment as follows:

1. Page ~~34~~⁴¹, line ~~21~~¹³: delete lines ~~21~~¹³ and ~~22~~¹⁴ and substitute:

“(c) The sheriff may award a grant to a person under this subsection for the construction or improvement of a shooting range only if all of the following apply:

1. The shooting range will be open to the public.
2. The person agrees to provide, for a fee of not more than \$20, a”.

2. Page ~~35~~⁴¹, line ~~14~~¹⁷: delete lines ~~14~~¹⁷ and ~~15~~¹⁸ and substitute:

“(d) In selecting grant recipients under this subsection, the sheriff shall do all of the following:

1. Give priority to applications that are made with respect to shooting ranges that are or will be owned by municipalities.
