#### SENATE AMENDMENT.

# TO SENATE SUBSTITUTE AMENDMENT (LRBs 0161/8), TO 2003 SENATE BILL 214

At the locations indicated, amend the substitute amendment as follows:

1. Page 19, line 19 after that line insert:

"(16m) CHECKING WEAPONS. (a) Any building owned or leased by the state or by any political subdivision of the state that has security personnel and in which licensees or out—of—state licensees are prohibited under sub. (16) from carrying a concealed weapon shall have security personnel provide a place for a licensee or out—of—state licensee to store his or her handgun while the licensee or out—of—state licensee is in the building.

(b) The security personnel who are providing a place to store a handgun under par. (a) shall charge the licensee or out-of-state licensee a fee of \$10 for the administrative and staffing costs of storing the handgun.".
