1 At the locations indicated, amend the engrossed bill as follows:

2 1. Page 2, line 2: delete "and providing penalties" and substitute "providing
3 penalties, and making an appropriation".

4 2. Page 7, line 1: before that line insert:

5 "SECTION 1c. 20.455 (2) (bx) of the statutes is created to read:

6 20.455 (2) (bx) *Reimbursement of certain costs incurred by counties in licensing*
7 *the carrying of a concealed weapon.* A sum sufficient to pay counties the costs
8 certified under s. 175.50 (19m).".

9 3. Page 7, line 1: delete "SECTION 1" and substitute "SECTION 1m".

10 4. Page 49, line 2: after that line insert:

issued, renewed, revoked,
or denied

11 "(19m) REIMBURSEMENT OF CERTAIN COUNTY COSTS. Annually, any county that
12 has incurred costs ^{associated with} ~~relating to the issuance or renewal~~ of licenses under this section
13 shall certify to the department the amount of those costs that are not covered by any

1 fees paid to the county under sub. (7) (bd), (13), or (15) (b) 4. a. No later than 60 days
2 after receiving the certification, the department shall reimburse the county for the
3 certified costs.”
