At the locations indicated, amend the bill as follows:

1. Page 46, line 10: after that line insert:

"(ax) 1. In this paragraph, "community center zone" means in or on the grounds of, or within 1,000 feet from the grounds of, a community center, a youth center, or a senior citizen community center.

- 2. No individual may knowingly carry a concealed weapon in a community center zone unless one of the following applies:
- a. The individual is on private property that is not part of the grounds of the community center, youth center, or senior citizen community center.
  - b. If the weapon is a handgun, the handgun is unloaded and encased.
- c. The individual possesses the weapon under a contract entered into between a community center, youth center, or senior citizen community center in the community center zone and the individual or an employer of the individual.

- d. The individual is traversing the grounds of a community center, youth center, or senior citizen community center for the purpose of gaining access to public or private lands open to hunting, if the entry on those grounds is authorized by the community center, youth center, or senior citizen community center and, if the weapon is a handgun, it is unloaded.".
  - 2. Page 47, line 21: after "(16)" insert "(a), (at), (b), (c), or (cm)".
  - 3. Page 47, line 22: after that line insert:
  - "(bx) Any person who violates sub. (16) (ax) is guilty of a Class I felony.".
